## STRATHALBYN TREASURE MARKET 18 August 2019

### NOTES

Please keep these notes for future reference.

1. Stallholders selling food must comply with the very specific regulations set out by the Alexandrina Council. For a copy of the requirements contact the Council at 11 Cadell St Goolwa or [www.alexandrina.sa.gov.au](http://www.alexandrina.sa.gov.au)
2. There are no sheltered areas on the oval so the site size is sufficient to allow you to trade from your vehicle or to erect a small marquee in front of your vehicle. If your site is larger than 6m x 4m you will be charged for an additional site on the day.
3. No power is available on the oval. Limited power is available in the hall for indoor stalls.
4. All stallholder electrical equipment, leads, power-boards, etc must have current test and tag information attached.
5. Only one vehicle per site is permitted. Additional vehicles may be parked behind the Football Club building prior to 8am.
6. To secure marquees on the oval or surrounds pegs no longer than 200mm may be used.
7. Stalls must stay open until 4pm.
8. No vehicles are to be moved before 4pm.
9. Sites must be left clean and free of rubbish. A skip bin is provided on site.
10. No firearms, weapons, medicines, pornography, dangerous goods, or any other material deemed offensive or objectionable will be displayed or offered for sale.
11. No livestock is to be offered for sale.
12. The selling of lottery tickets is not permitted.
13. No loudspeakers or any other equipment for amplifying sound shall be used at any time.
14. By participating in this event stallholders provide authority to the STA to use photos taken by association members on our website, social media pages, signs and print material.
15. Please show respect to the local community by keeping noise to a minimum, especially prior to 8am.
16. Traffic Marshalls will be in attendance and stallholders must follow their directions.
17. Completed application forms and full payment is required by 31<sup>st</sup> July 2019. Receipts will be issued at the event on 18<sup>th</sup> August 2019.
